<u>Liability Statement:</u> A parent/guardian of an underage consignor shall execute the consignment form provided by PCLA. A consigner who is of age to sign for themselves shall provide proof of age to the Board of Directors at the time of consignment. Any unpaid debt from the PCLA Sponsored Youth Livestock Sale up to 5% of the most recent annual gross sale shall be paid by PCLA until it is collected from the buyer(s). The Board of Directors may adjust this percentage if unforeseen circumstances outside of the control of the Board of Directors justify such action. The Board of Directors may establish exceptions to this rule if PCLA's financial circumstances allow said action and two-thirds (2/3) of the directors vote in favor of adjustment.

COVID-19 Coronavirus Release Waiver: The novel coronavirus, Covid-19, has been declared a worldwide pandemic by the World Health Organization. Covid-19 is extremely contagious and is believed to spread from person-toperson contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing. The Preston County Livestock Association (PCLA), PCLA officers, board of directors, members, volunteers, and other attendees cannot quarantee that you (exhibitor/parent/guardian/spectator/buyer) will not become infected with Covid-19. Further, attending any event hosted by the Preston County Livestock Association during the 2023-2024 year could increase your risk of exposure of contracting Covid-19. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Preston County Livestock Association, PCLA officers, board of directors, members, volunteers, and other attendees, whether a Covid-19 infection occurs before, during, or after participation in the Preston County Livestock Association event.

<u>Authorization for Photo Release</u>: This authorization is to include the following: newspaper, print, internet, public media, social media, social networking, etc.

The Preston County Livestock Association (PCLA) may, as in any other public media systems, publish news type information and pictures such as group shots, distance shots, action shots, and/or pictures from the side or back of youth members along with youth members' first names. However, the PCLA will not take easily identifiable head and shoulders shots of your child and use their full names without the parent's consent. You may grant consent for the latter type of pictures and names to appear on the PCLA's website or social media sites by answering the two following questions with a yes.
